I, INV. JORGE GONZALEZ, do solemnly swear that I have good reason to believe, and do believe and charge, that heretofore, on or before the 31 day of DECEMBER A.D. 2018, in the County of Hidalgo and State of Texas, MICHAEL GABRIEL SOSA, hereinafter called Defendant, did then and there during a period that was 30 or more days in duration, namely from on or about January 1, 2016 through December 31, 2018, when the defendant was 17 years of age or older, commit two or more acts of sexual abuse against PSEUDONYM- Lisa Garza, a child younger than 14 years of age, namely the defendant caused his sexual organ to make contact with the mouth of the child on multiple occasions and with intent to arouse or gratify their sexual desire.

PC STATEMENT (Page 1 of 1)

On February 10, 2024 (pseudonym) Lisa Garza, who is now 16 years old, made an outcry to her parents stating her half-brother Michael Gabriel Sosa, had sexually assaulted her when she was in elementary school.

On February 15th, Inv. J. Gonzalez # [REDACTED] attended the forensic interview of Lisa Garza and observed her statement regarding the outcry. Lisa stated while she was in elementary between the ages of 8 years old to 10 years old, Michael had her perform fellatio on his sexual organ with her mouth while she was kneeling down in front of him inside a locked bathroom at home. Lisa could clearly recall in one of these instances that Michael had ejaculated into her mouth. On a separate incident Michael was feeling Lisa's breast over her shirt complimenting her on how mature she was getting. Lisa stated the last time Micheal attempted to have sexual deviate intercourse with her she refused; instead sucking on Michael's fingers instead of his sexual organ for his sexual gratification.

Thus Inv. J. Gonzalez # [REDACTED] is seeking a warrant for Michael Gabriel Sosa (DOB [REDACTED]) for Continuous Sexual Abuse of a Young Child or Disabled Individual, a First-Degree Felony.
